 - Labour Act, No. 11 of 2007 as amended
 - Occupational Health and Safety Regulations No. 18, 1997
 - White Paper on Labour Based Works Policy, 1999 and all subsequent amendments.

Performance Criteria

- 1.1 The philosophy, principles and concepts of the labour based works policy are described.
- 1.2 The importance of labour based works policy is aligned with policies for employment creation and income generation for disadvantaged groups without being unfair or exploitative.
- 1.3 The importance of labour based works policies is aligned with policies for poverty eradication, community development and participation.

Element 2: Demonstrate knowledge of the applications of the labour based works policy

Performance Criteria

- 2.1 The critical aspects and provisions of the "White Paper on labour based works policy" are described in terms of employment creation.
- 2.2 The underlying principles to be applied to labour based works such as to perform these in a socially responsible, cost effective and qualitatively compliant manner are described.
- 2.3 Ways and areas where the labour based works policy may be applied in the road construction and maintenance industry in accordance with the underlying principles, inclusive of the involvement of SME's, are identified.
- 2.4 Factors to be considered in applying the labour based works policy are identified in terms of distance to and from the construction site, geological structures in the site locality, local cultural mores, execution of projects and economic feasibility.
- 2.5 The rights and obligations of the different parties involved in the application of labour based works policy are identified.
