## **1 purpose**

This qualification recognises people who have the competencies required for performing bricklaying and plastering tasks. It is awarded to people who have demonstrated the skills and knowledge required to perform a range of bricklaying and plastering tasks, including performing calculations, estimations and measurements related to bricklaying operations, carrying out levelling, excavation and setting out operations, building basic brick structures, performing basic rendering, plastering and concreting tasks and using plastering and concreting hand tools; and demonstrate knowledge of HIV and AIDS in the workplace.

This qualification is designed to be accessible and flexible. The entry requirement for this qualification is the National Vocational Certificate in General Construction (Level 1) (Bricklaying) or equivalent.

The main focus is on the outcomes of this qualification, not the how, when and where learning occurred. Some people applying to do this qualification may currently be competent in one or more of the unit standards and should then be given the opportunity to apply for recognition of prior learning.

This qualification leads to the National Vocational Certificate in General Construction (Level 3) (Bricklaying).

This qualification will be awarded to people who are credited with 42 credits and have met the requirements of the compulsory sections.
