inequality in society

<u>Purpose</u>

This unit standard specifies the competencies required to demonstrate knowledge of the impact of inequality in society. It includes knowing the measures of inequality in society and describing the impact of inequality in society. This unit standard is intended for people who work or who wish to work in civil society organisations and it will increase the effectiveness of people working in development by giving them a conceptual framework of the underlying sociological issues.

Special Notes

- To demonstrate competence, at a minimum, evidence is required from a workplace or simulated workplace or an appropriate simulated environment where knowledge of inequality and its impact is demonstrated.

Elements and Performance Criteria

Element 1: Demonstrate knowledge of the measures of inequality in society.

Range

Variables by which inequalities are identified include but are not limited to income, land rights, level of civic involvement, literacy, access to education, educational achievement,

access to health care, access to maternity care, availability of power supply, availability of water and types of sanitation.

Quantitative measures are made of all the variables and additionally the Gini Coefficient is a statistical measure of inequality of income distribution or inequality of wealth distribution.

Qualitative descriptions are also made concerning for example people's living conditions, their confidence, self-esteem and motivation.

Performance Criteria

- 1.1 Variables for which inequalities within a nation are identified are listed in terms of both developed and developing worlds.
- 1.2 Inequalities within Namibian society are explained in terms of their relative prevalence, significance, impacts, corrective measures and trends over time.
- 1.3 Quantitative measures of inequality are known and interpreted through the use of three specific data sets.

Element 2: Explain the impact of inequalities in society.

Range

Democratic processes include but are not limited to being informed about and participating in local, regional and national elections.

National development includes but is not limited to economic growth, participation and attainment in education, participation in democratic processes, provision of healthcare, levels and types of infrastructure and social conditions.

Personal growth and development includes but is not limited to levels of fulfilment, motivation and self-esteem.

Performance Criteria

- 2.1 The impacts on democratic processes are explained by using contrasting case studies
- 2.2 The impacts on national development are explained in terms of how inequalities inhibit development.
- 2.3 The impacts on personal growth and development are explained by using case studies.
